

ORDINANCE NO. ____

AN ORDINANCE AMENDING SECTION 1-2-3 OF CHAPTER 1-2 OF TITLE 1 OF THE ROCHESTER CODE OF ORDINANCES RELATING TO ADMINISTRATIVE ENFORCEMENT PROCEDURES.

THE COMMON COUNCIL OF THE CITY OF ROCHESTER ORDAINS:

Section 1. Section 1-2-3 of Chapter 1-2 of Title 1 of the Rochester Code is hereby amended to read as follows:

Sec. 1-2-3. Code provisions that are administrative offenses.

- (9) Gambling regulations (chapter 8-10);
- (10) Vending carts (chapter 9-10);
- (11) Street and sidewalk regulations (chapter 9-1);
- (12) Repeat nuisance service calls (chapter 8-4);
- (13) Sidewalk maintenance (section 9-6-2);
- (14) Public urination (section 8-7-5);
- (15) Outdoor dog permit (chapter 3-2);
- (16) Housing code: registration of rental units (chapter 7-5);
- (17) Piling of snow (section 11-8-6);
- (18) Tall grass and weed regulations (chapter 8-5);
- (19) Sidewalks, driveways, curbs, curb cuts, and streets (title 9);
- (20) Sewers (section 12-2-3).
- (21) Building and Building Regulations (Chapter 4-3);

- (22) Taxicabs (Chapter 5-5);
- (23) Sign Contractors (Chapter 5-8);
- (24) Adult Entertainment (Chapter 5-11);
- (25) Transportation Network Companies (Chapter 5-6)
- (26) Pawnbrokers (Chapter 5-13);
- (27) Door-To-Door Sales and Solicitations (Chapter 5-15)
- (28) Massage Therapists and Massage Therapy Businesses (Chapter 5-15);
- (29) Fireworks Dealers (Chapter 5-16);
- (30) Ice Cream Vendors (Chapter 5-20);
- (31) Mobile Food Units (Chapter 5-21);
- (32) Public Transportation (Chapter 5-22);
- (33) Cannabis (Chapter 5-23);
- (34) Special Events (Chapter 8-11);
- (35) Public Right of Way Management (Chapter 9-6);
- (36) Sidewalk Cafes, Street Cafes and Parklets (Chapter 9-8).

Section 2. This ordinance shall become effective from and after its publication.
